Details of the Committees and SOP have been displayed on the college notice board and website.

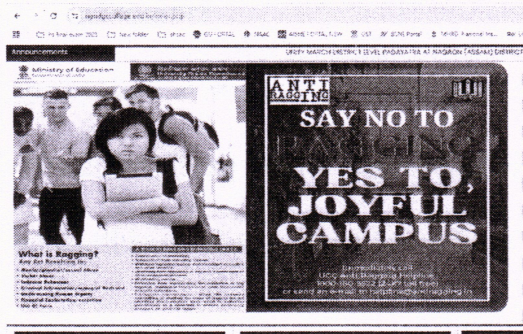

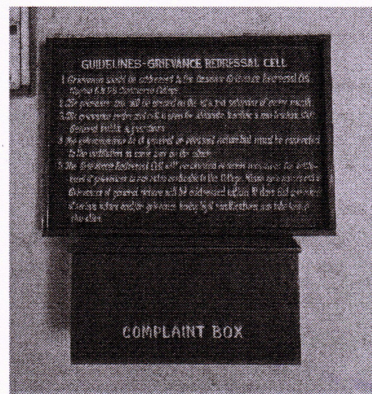
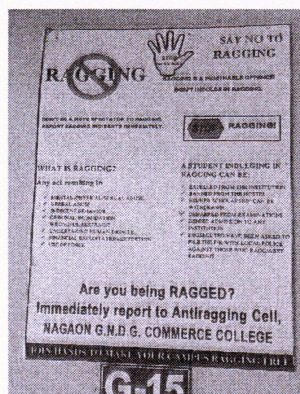

- The college has ensured confidential and prompt handling of any complaints.


### **7. Zero-Tolerance Policy**
